Awareness of Coercive Control Training

All frontline professionals and managers working to safeguard children and adults need to understand how coercive and controlling behaviour impacts upon the whole family. Only if they have an appreciation of the mechanics of this devastating form of abuse, will they be able to understand WHY their efforts to support a victim are so often undermined. An awareness of the 'technology of control' prepares them to respond more effectively thereby empowering victims. Our multiagency training on Coercive Control based upon a case study enables professionals to identify why safeguarding may be frustrated and provides the tools to best equip professionals.

The Serious Crime Act 2016 section 76 created a criminal offence relating to coercive and controlling behaviour. All professionals need to understand how they can support victims to recognise that what they have experienced is a crime.

Objectives of Coercive Control Training include:

- Explaining what coercive control is along with examples of such behaviour.
- Recognising how patterns of coercive control develop in Domestic Abuse and their impact on adults and children at risk.
- Recognise that the tactics used by abusers can prevent non-abusing partners and children seeking help. But also prevent practioners safeguarding those who are vulnerable.
- Understand how to review and apply the learning to allocated cases.
